

Subject: Implementation of 2nd factor biometric authentication through FIDO device to access PFMS.

As you are aware that PFMS has already implemented the use FIDO device for Delhi based 120 PAOs using e- bill utility for payment execution (First & Second level signatory). Now it has been decided by the DoE to roll out this functionality among all the PAOs of Ministries / Department.

2. Reference is also invited on the OM dated 03/05/2023 issue by the GIFMIS section O/o CGA regarding Implementation of New Window based Digital Signing utility in place of existing Java based utility in the sanction module of PFMS w.e.f 01/06/2023. All Ministry / Department may ensure that the action stated in the above mentioned OM has been complied with.

3. In view of the above, Pr.CCAs / CCAs /CAs with (I/C) of all the Ministries / Departments are requested to issue necessary instructions to their respective PAOs (Local and Outstation) to procure the FIDO device by **31.07.2023** as per specification provided in the Annexure -'A' only after ensuring the compliance as per point 2 above as this 'browser Neutral DSC utility is the pre- requisite of FIDO implementation.

4. All Pr.CCAs / CCAs /CAs with (I/C) of the Ministry / Department are requested to provide the consolidated report on procurement status of FIDO device by their respective PAOs in the given format (Annexure-B) to PFMS by **31.07.2023** for necessary action at this end.

5. A comprehensive training on the FIDO activation will be conducted through VC for all the users as per Annexure- C. All Pr.CCAs / CCAs /CAs with (I/C) are to ensure the participation of the PAOs (First & Second signatory user) in the training.
