This Office has been receiving grievances from Pensioners/Family Pensioners that they are not receiving monthly Pension Slip from their Pension Disbursing banks.

- Reference is invited to the DP&PW's O.M. No. 1(4)/2021-P&PW(II)-7223 Dated 22nd June, 2021 (Copy enclosed) vide which CMDs and CPPCs of all pension disbursing banks were clearly instructed to issue pension slip to Pensioners after credit of pension on their registered mobile numbers through SMS and email also. The pension slip should provide complete details of monthly pension paid along with break-up of the amount credited and tax deductions etc. if any.
- The CPPCs of all Pension Disbursing Banks are advised to take necessary action to ensure that the pensioners/family pensioners receive the pension slip invariably every month. It may be ensured that these slips are generated in a suitable and well-laid-out format and fonts for easy readability by pensioners of all ages. The pension slip should provide complete details of monthly pension paid along with break-up of the amount credited and tax deductions etc.
- 3. The CPPCs of Pension Disbursing Banks are requested to ensure compliance of the above instructions for improving the "Ease of Living" for pensioners.
