CIRCULAR

Subject: Summary of bill pendency report in all PAOs of CBIC reg.

To avoid the rush of bills and accumulation of pending bills in the financial year closing for March 2024, it has been decided by the competent authority that-

1. All bills received should be cleared on the same day, after exercising all the checks.

2. Bill pendency report on daily basis must be sent to Head Quarter till 31.03.2024.

3. All PAOs may direct to their respective DDOs to submit all the bills upto 20th of march 2024 to avoid any rush at the last minute.

All Zonal Heads of CBIC are requested to circulate the same to all PAOs under their administrative jurisdiction for strict compliance of the instructions.

In case it is necessary to open the office on weekends in this month. Zonal Heads may decide considering the requirement and open the office accordingly.
