

3. Instructions for authorized Bank/branch:

- The collecting branch will render the scrolls and challans for receipts through the existing FPB i.e. SBI Centaur Hotel Branch IGI Airport Centaur Hotel, New Delhi (BSR Code-0008087), Outstation to PAO, Customs (Prev.), Jamnagar on daily basis. The branch is required to follow the procedure laid down in the "Revised Memorandum of Instructions for Collection and Accounting of Central Excise, Customs and Other Dues."
- A new e PAO (Code 018329) for auto-crediting of Drawback amount in the taxpayer's bank account through PIMS has started functioning w.e.f 05.06.2024 as per the instruction issued by Drawback division of O/o Central Board of Indirect Tax & Customs vide letter No. 140609/45/2023 Drawback Section-CBLC dated 29.05.2024.
- As per Circular No. 05/2025 Customs dated 17.02.2025, issued by the Under Secretary, Customs Policy Wing, Ministry of Finance, no manual refund applications shall be accepted after 31.03.2025.
