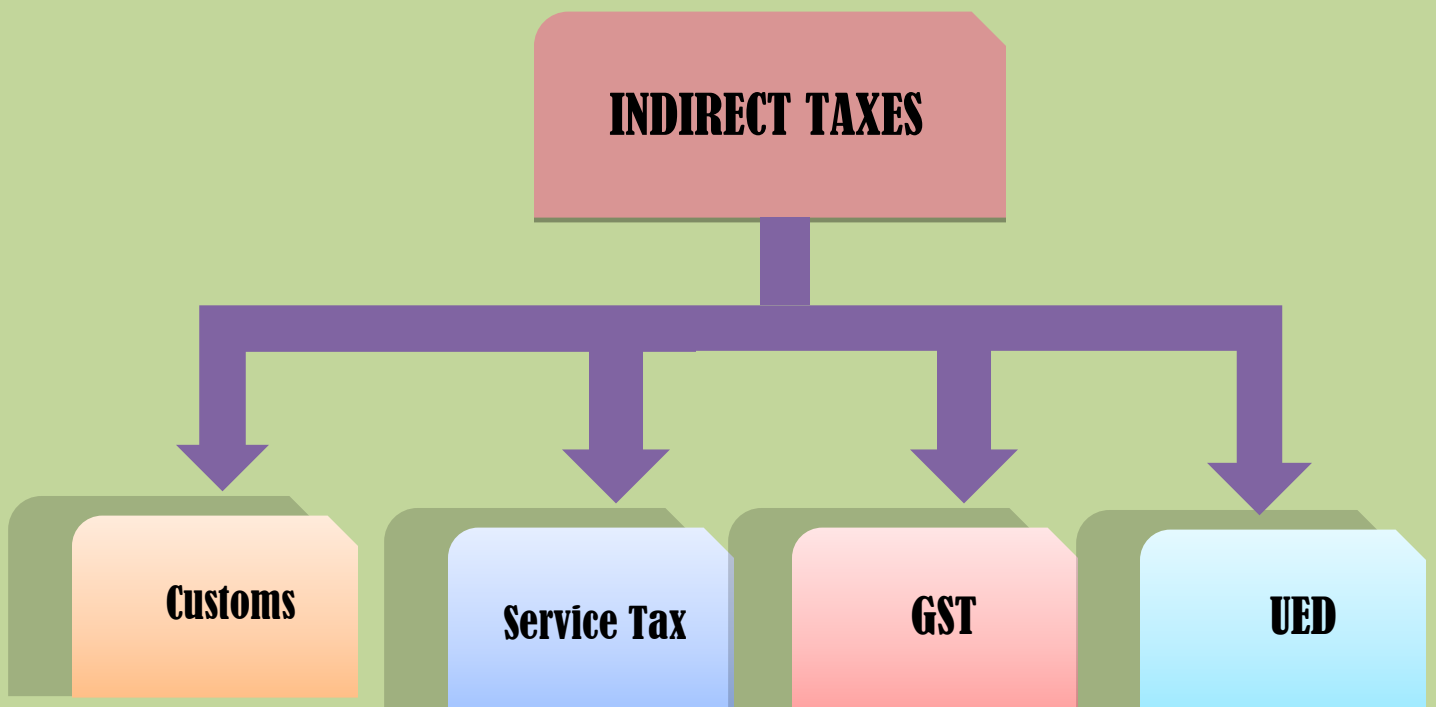

INDIRECT TAX COLLECTION

August, 2025

Executive Summary

Gross Collections

- Gross collection of Indirect Taxes (including GST) upto **August, 2025** is **Rs. 9,56,441.09 crore** in comparisons to **Rs. 9,18,203.87 crore** upto August in previous year, showing a growth of **4.16%**. Out of the Total Gross collection, the share of **CGST** is **Rs. 1,88,436.05 crore**, **UTGST (OT)** is **Rs. 148.65 crore**, **IGST** is **Rs. 4,94,213.60 crore**, **Compensation Cess** is **Rs. 64,023.05 crore**, **Custom Duty** is **Rs. 96,884.86 crore**, **UED** is **Rs. 1,12,545.12 crore** and **Service Tax** is **Rs. 189.76 crore**.

Net Collections (Total)

- Net collection upto **August, 2025** is **Rs. 6,48,221.12 crore** as compared to **Rs. 6,29,970.58 crore** upto August in previous year showing a growth of **2.90%**. The net collection is **37.36%** of the B.E. of **Rs. 17,35,100 crore**.

Custom Duty (Net)

- Net collection upto **August, 2025** is **Rs. 83,058.46 crore** which is **34.61%** of B.E.

Customs Duty drawback and Refund

- The Custom duty drawback & Refund payments upto **August, 2025** are **Rs. 13,826.40 crore**. (14.27% of Gross Collections)

Union Excise Duty (Net)

- Net collection of Excise Duty upto **August, 2025** is **Rs. 1,11,927.39 crore** which is **35.31%** of B.E.

Union Excise Duty Refund

- The UED Refund payments upto **August, 2025** are **Rs. 617.73 crore**. (0.55 % of Gross Collections)

Service-Tax (Net)

- Net collection of Service Tax **upto August, 2025** is **Rs. -241.14 crore** which is - **241.14% of B.E.**

Service Tax Refund

- The Service Tax Refund payments **upto August, 2025** are **Rs. 430.90 crore.** (227.08% of Gross Collections)

CGST (Net)

- Net Collection of CGST **upto August, 2025** is **Rs. 3,90,501.55 crore.** It includes the share of regular Settlements and Advance Apportionment from IGST, added through book adjustments.

UTGST (OT) (Net)

- Net Collection of UTGST (OT) **upto August, 2025** is **Rs. 644.77 crore.**

IGST (Net)

- Net collection of IGST **upto August, 2025** is **Rs. 369.82 crore.** This is after Refunds and monthly regular settlements as well as Advance Apportionments.

Compensation Cess (Net)

- Net (after Refund) collection of Compensation Cess **upto August, 2025** is **Rs. 61,960.27 crore.**

- *An amount of **Rs. 1,08,263.34 crore** has been paid as GST Refund upto August, 2025 with following details:*
 - *CGST:* Rs. 17,805.01 crore
 - *UTGST (OT)* Rs. 0.00 crore

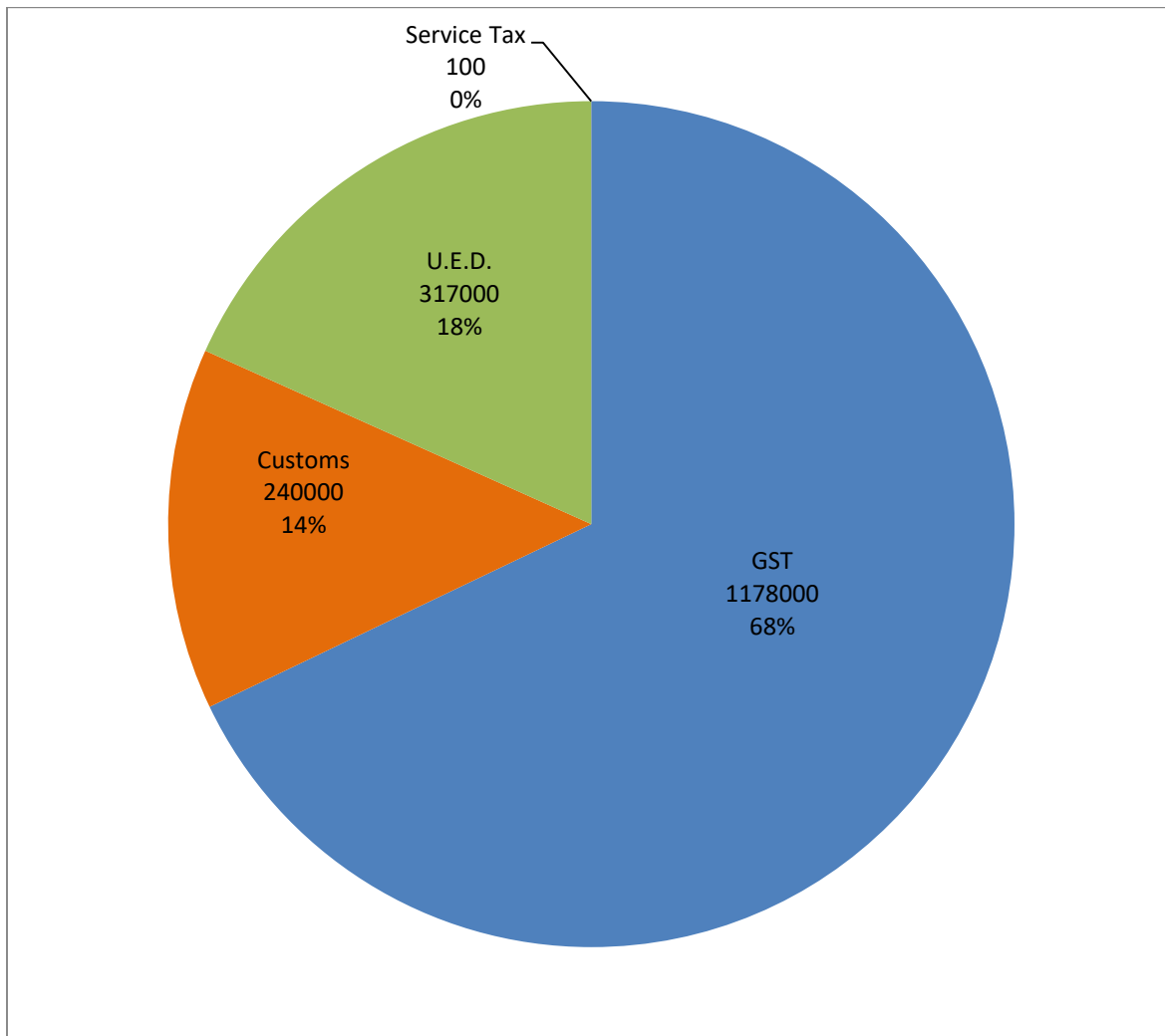

Total Budget Estimate Rs. 17,35,100 Crores



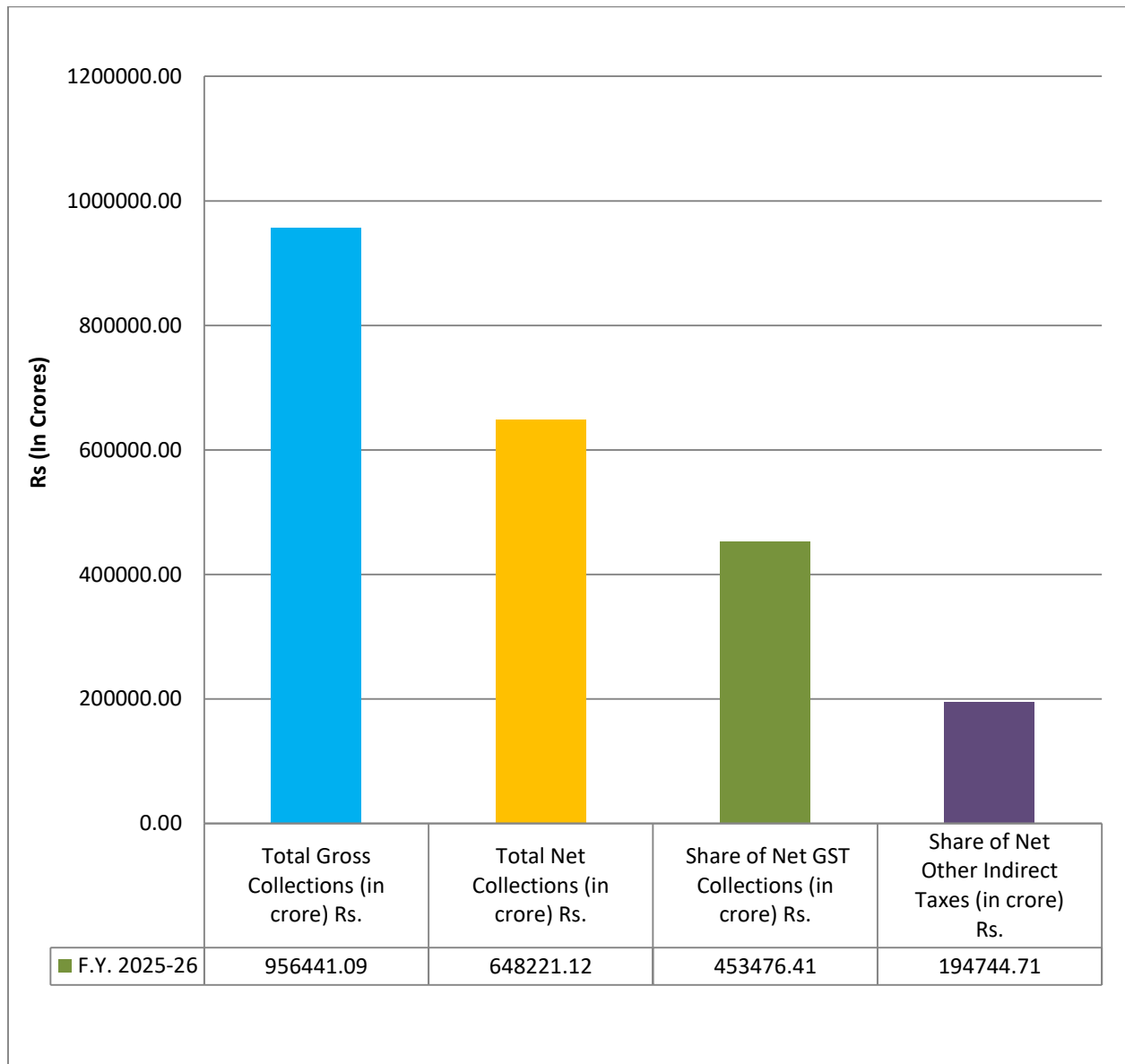

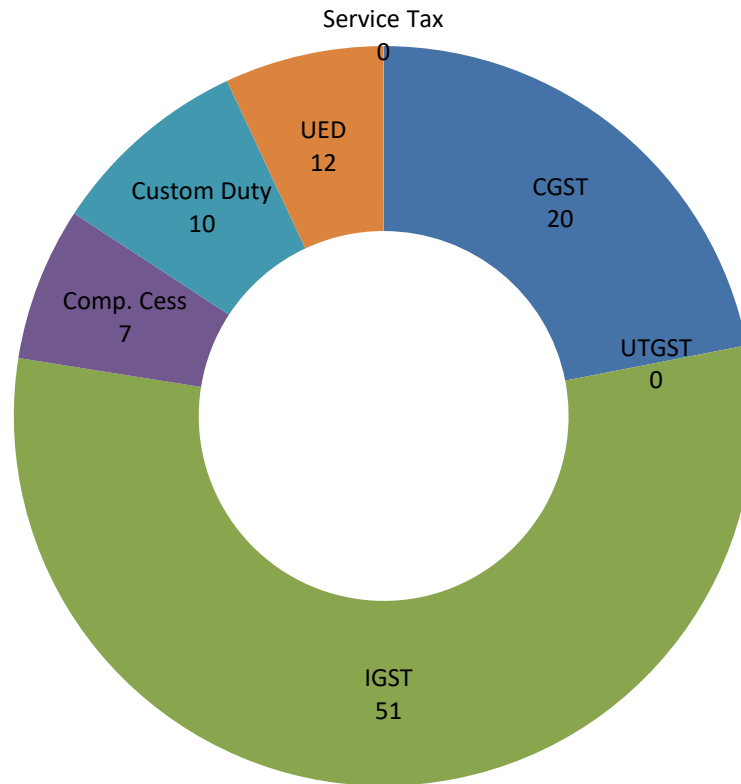

Gross Collection (in Percentage)



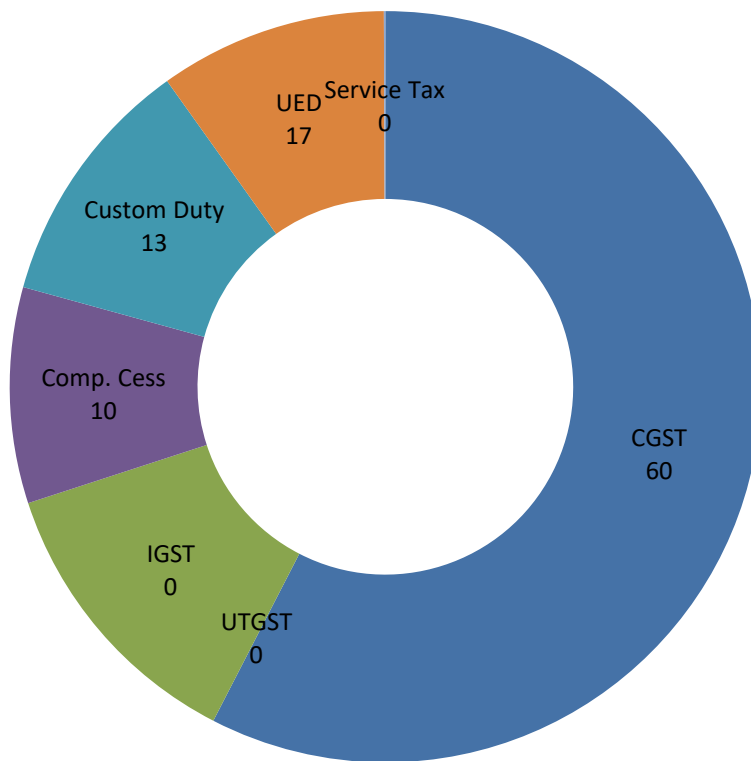

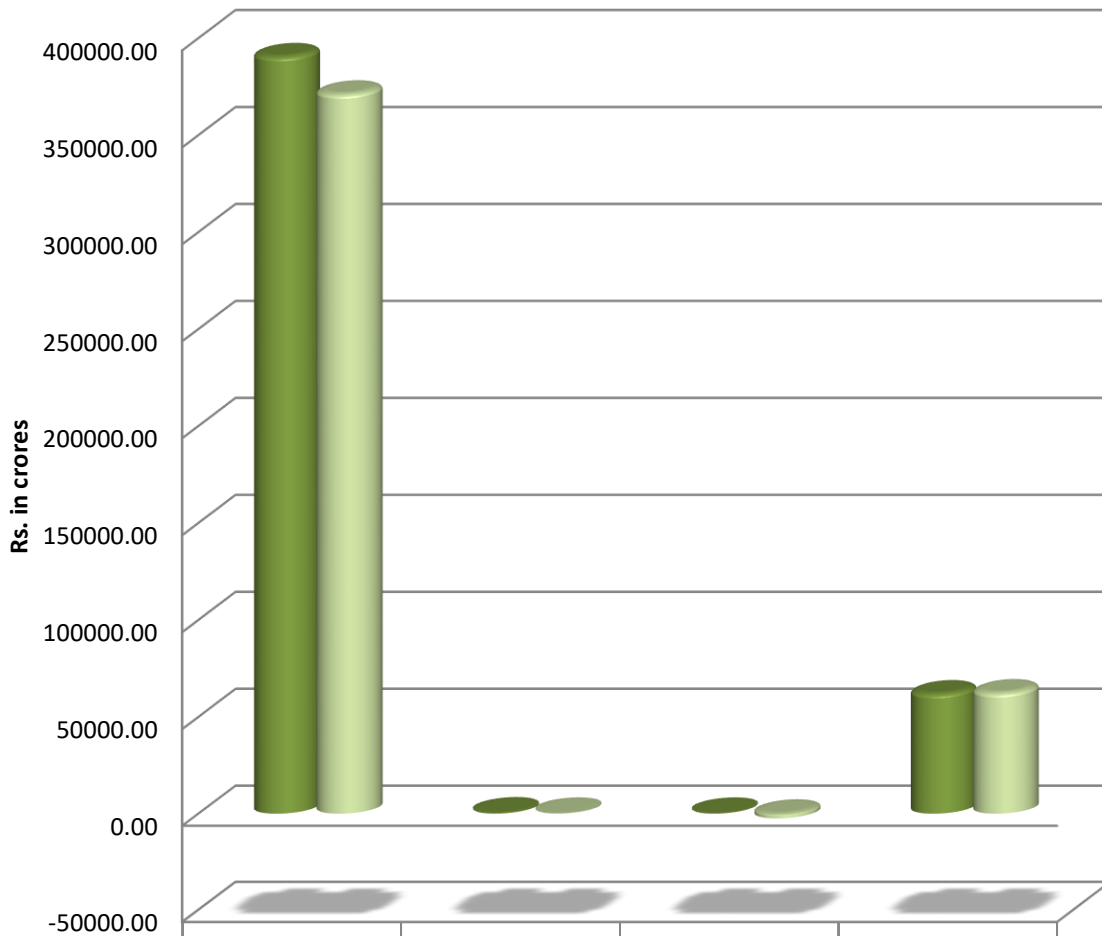

Net Collection (in Percentage)



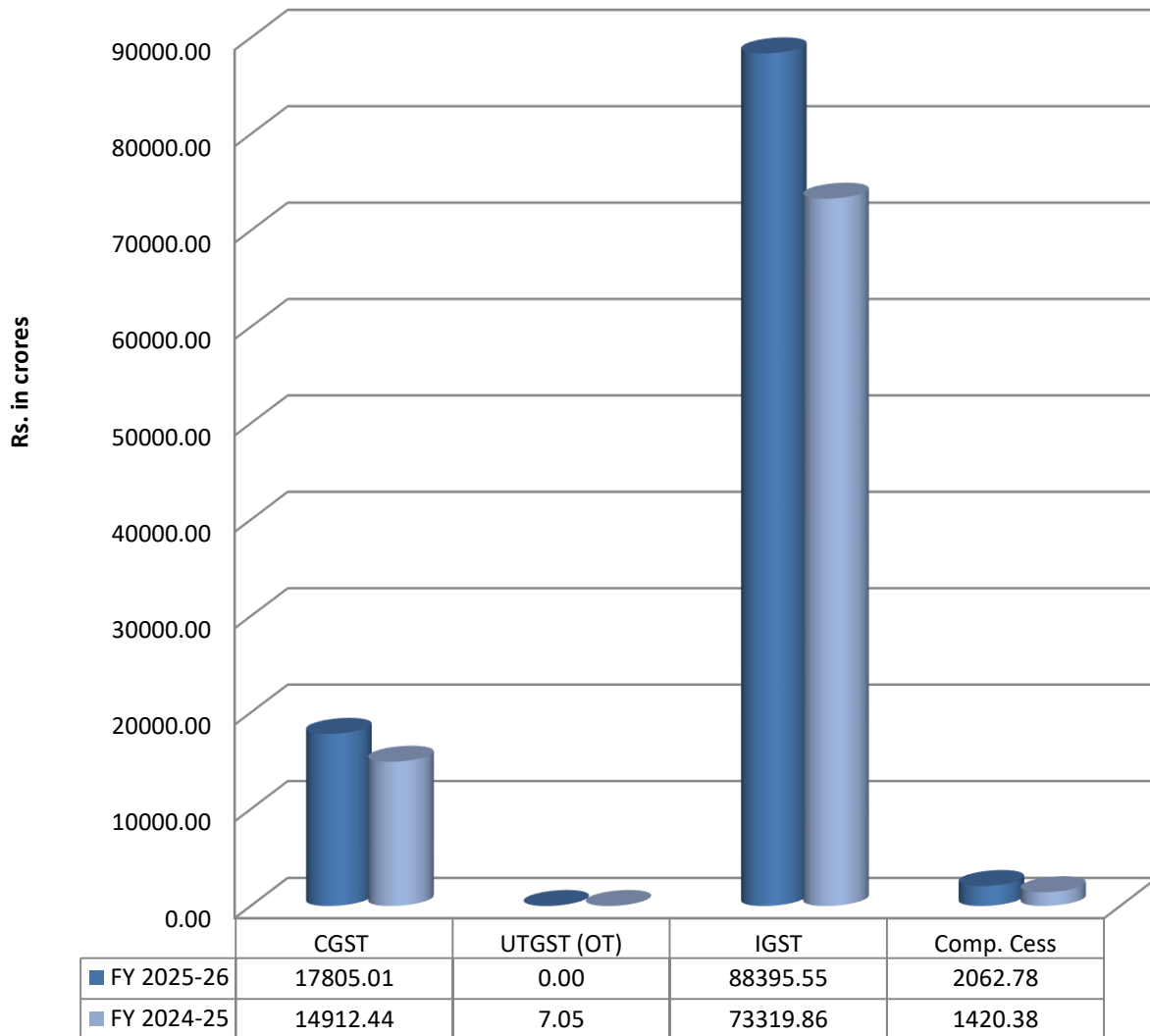

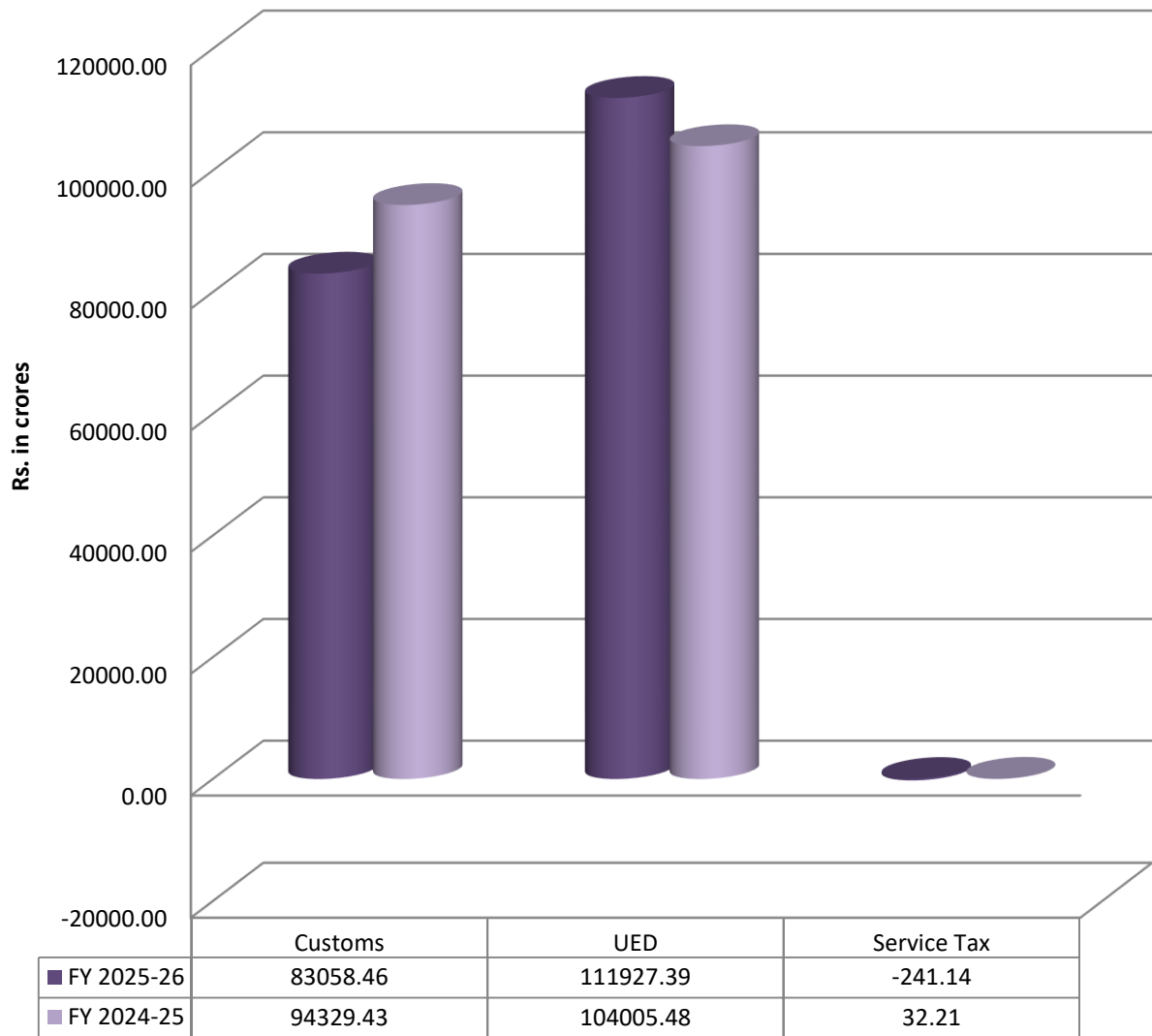

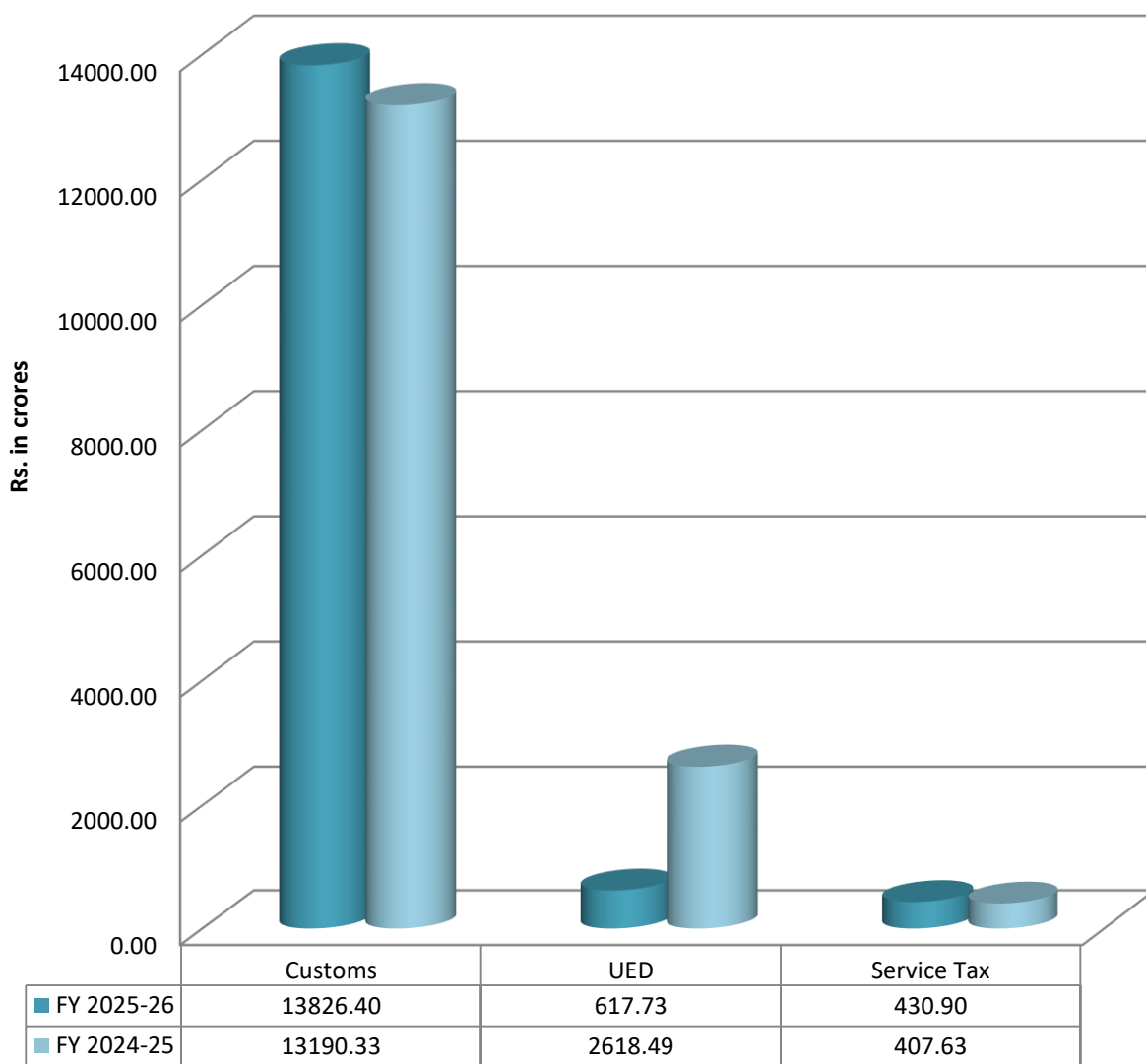

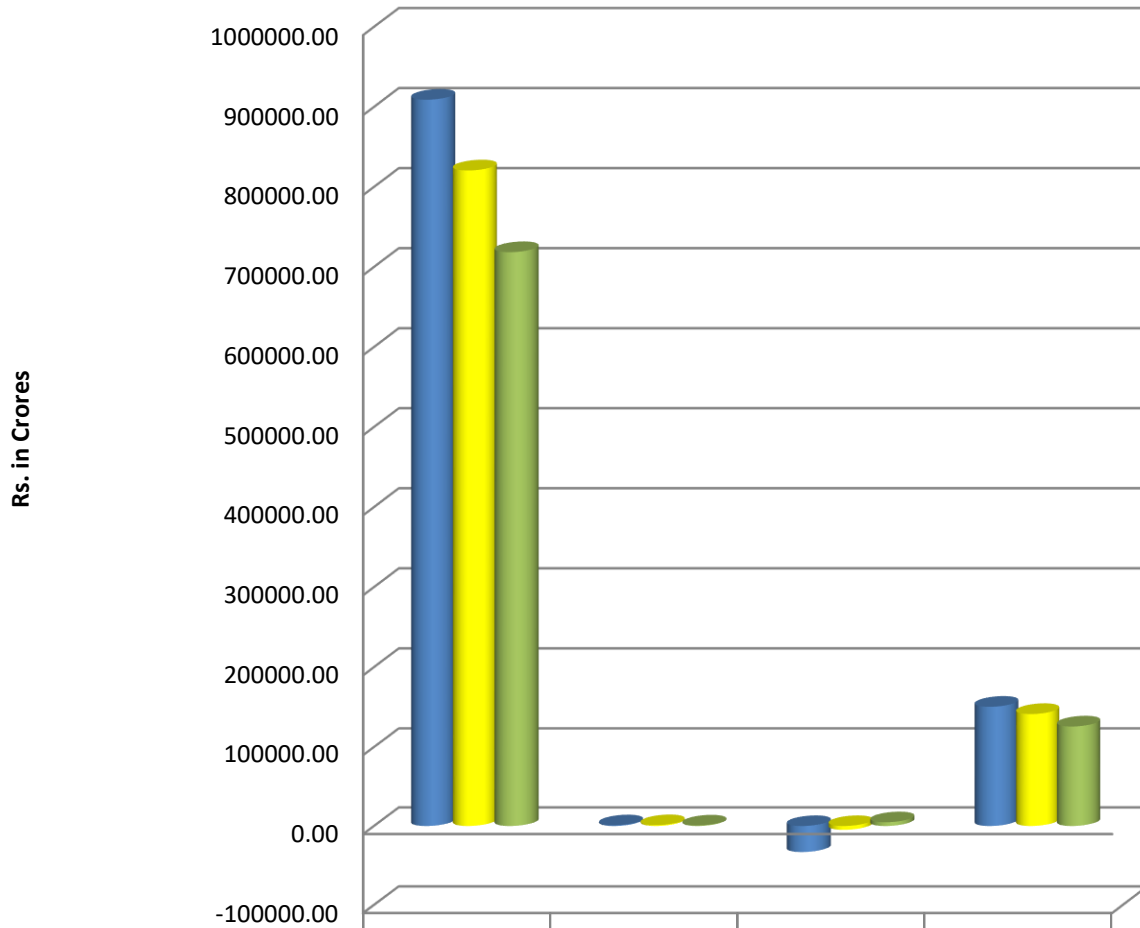
Non GST Net Collections upto August, 2025



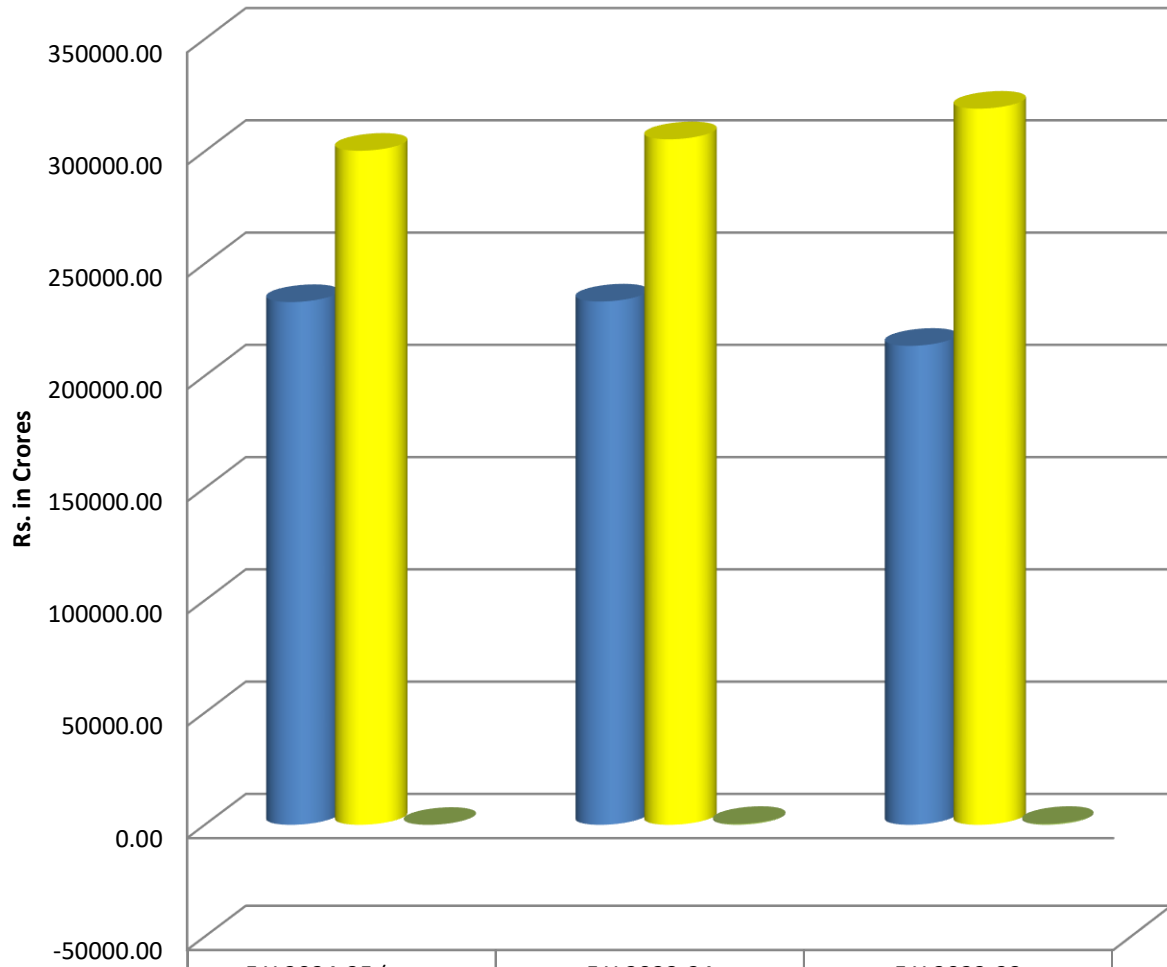

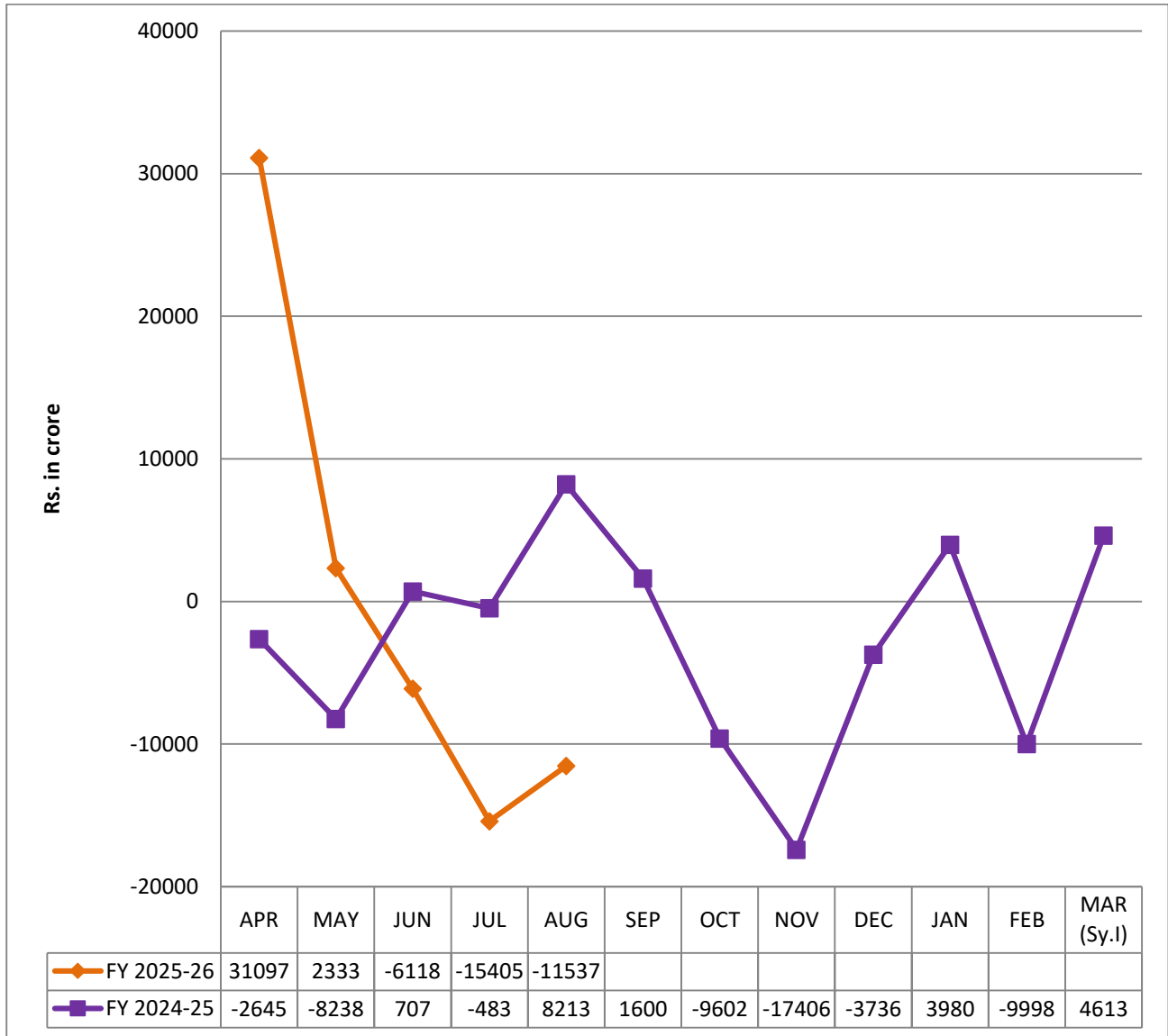

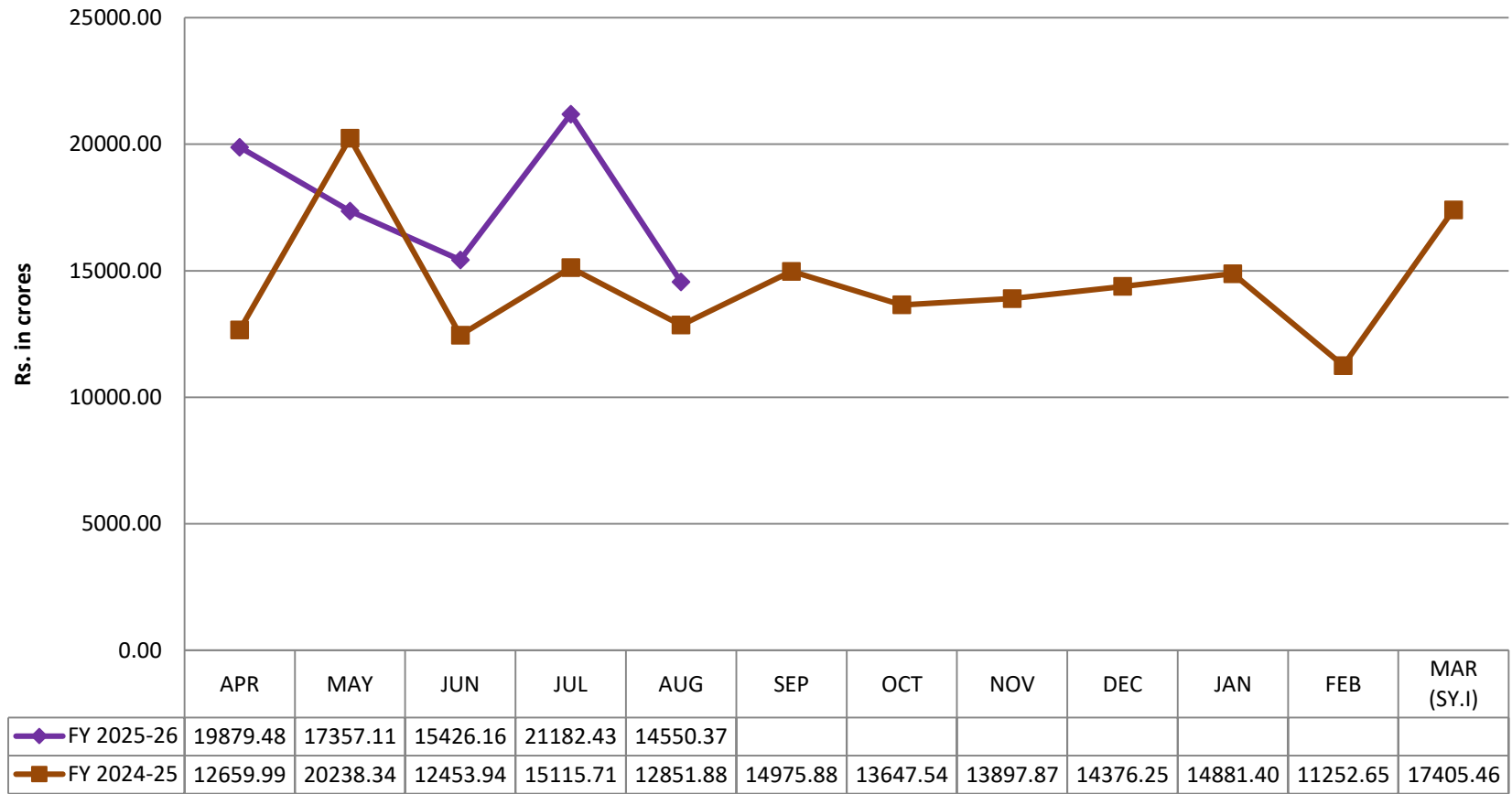

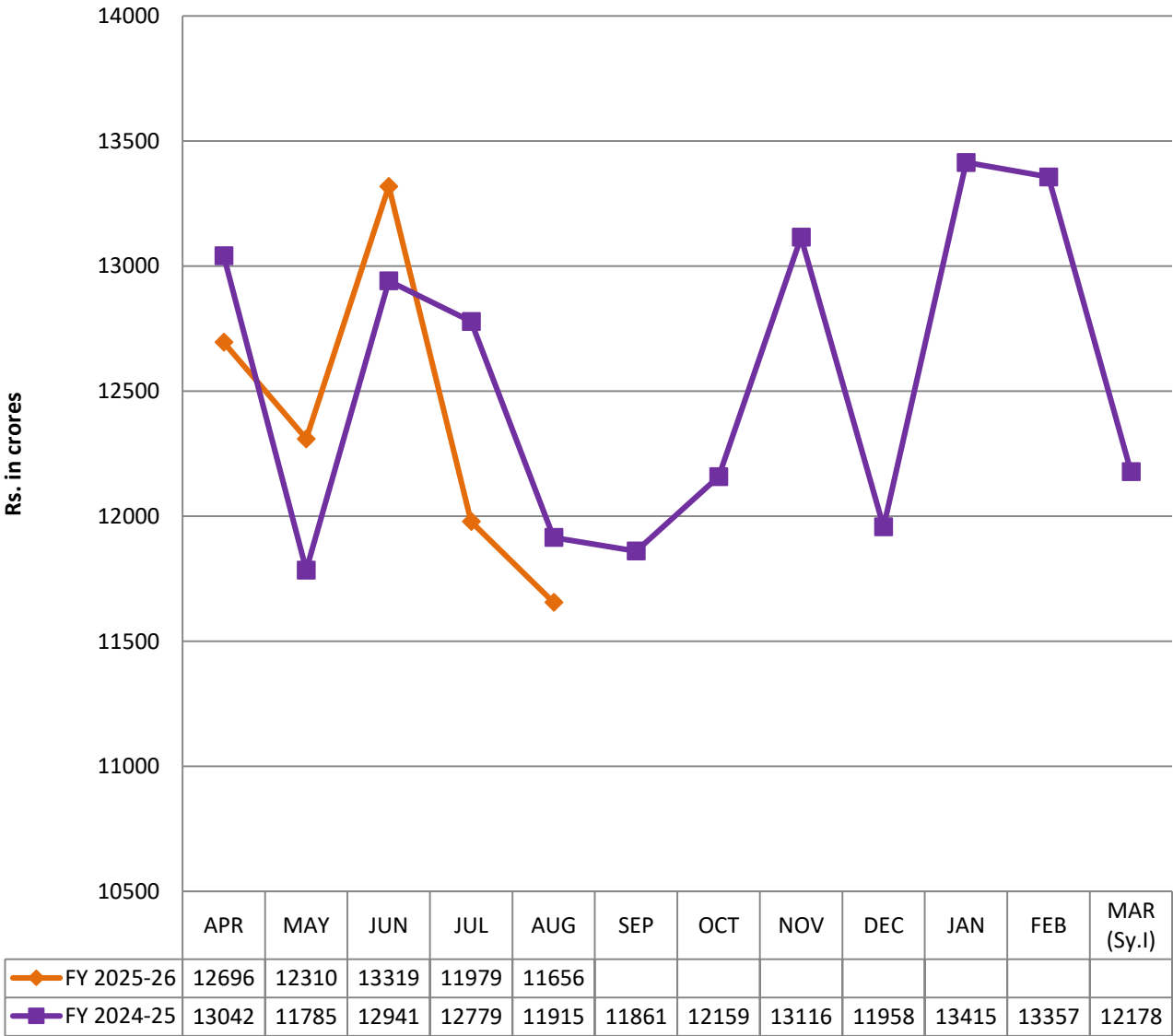

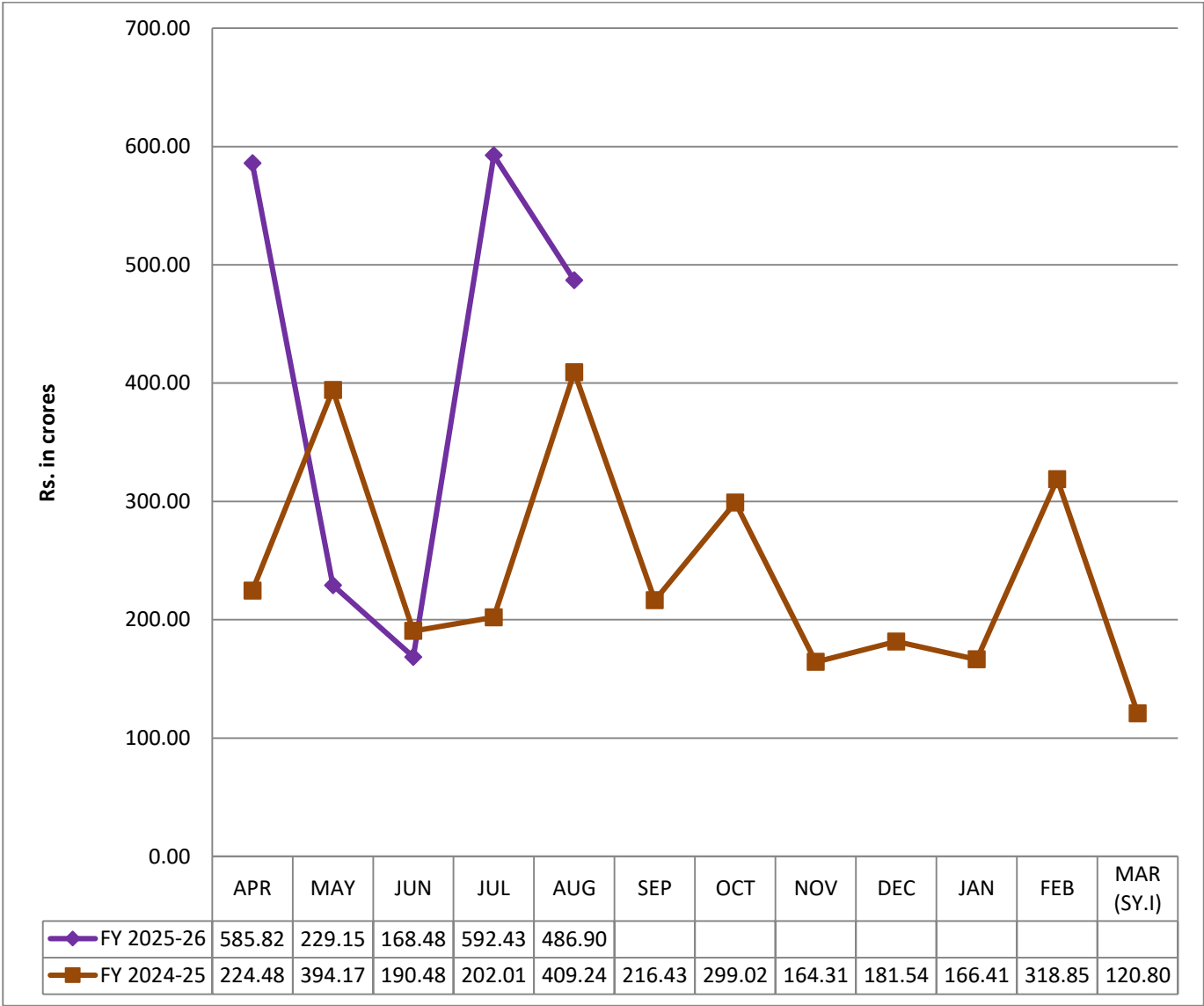

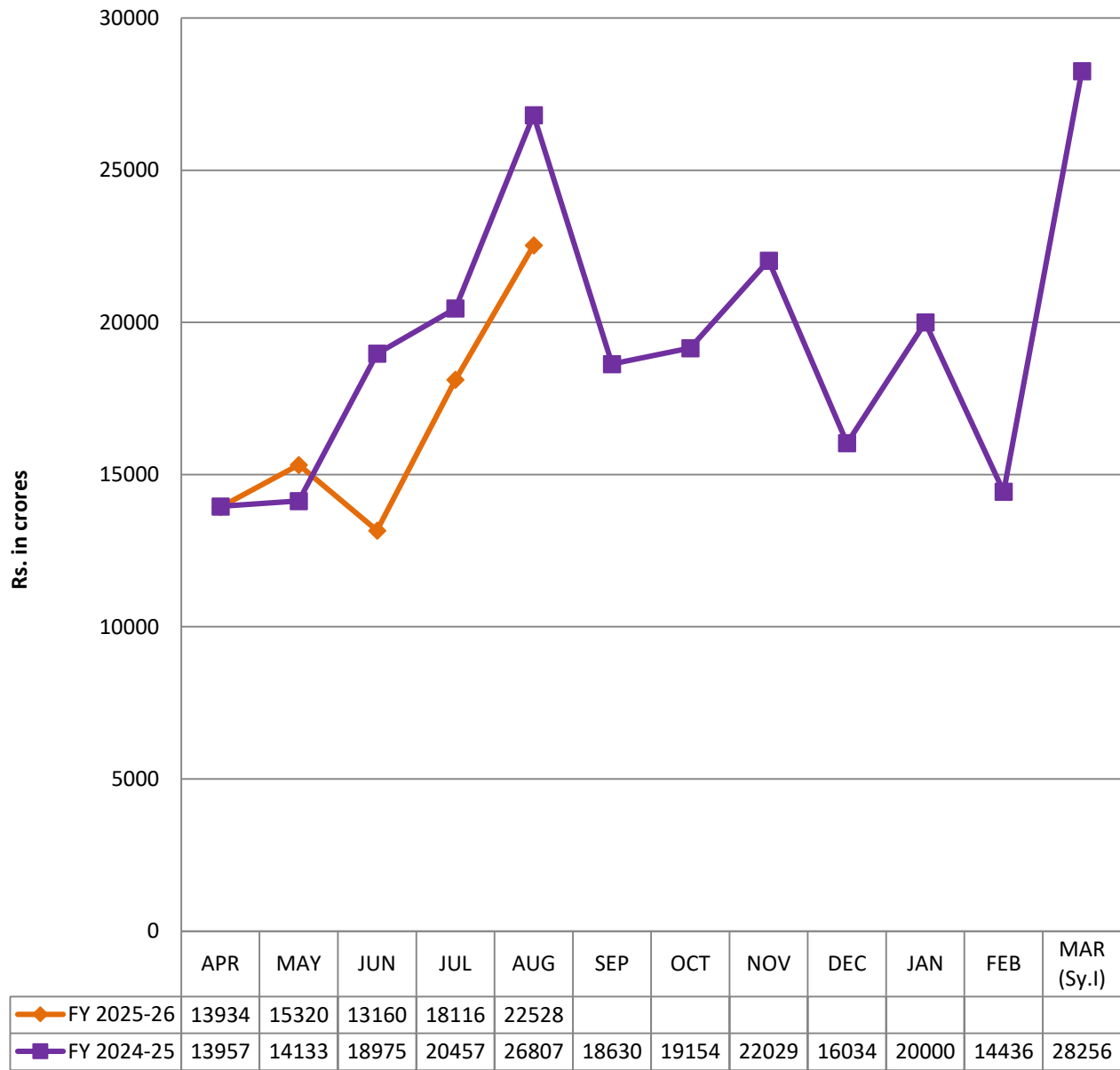

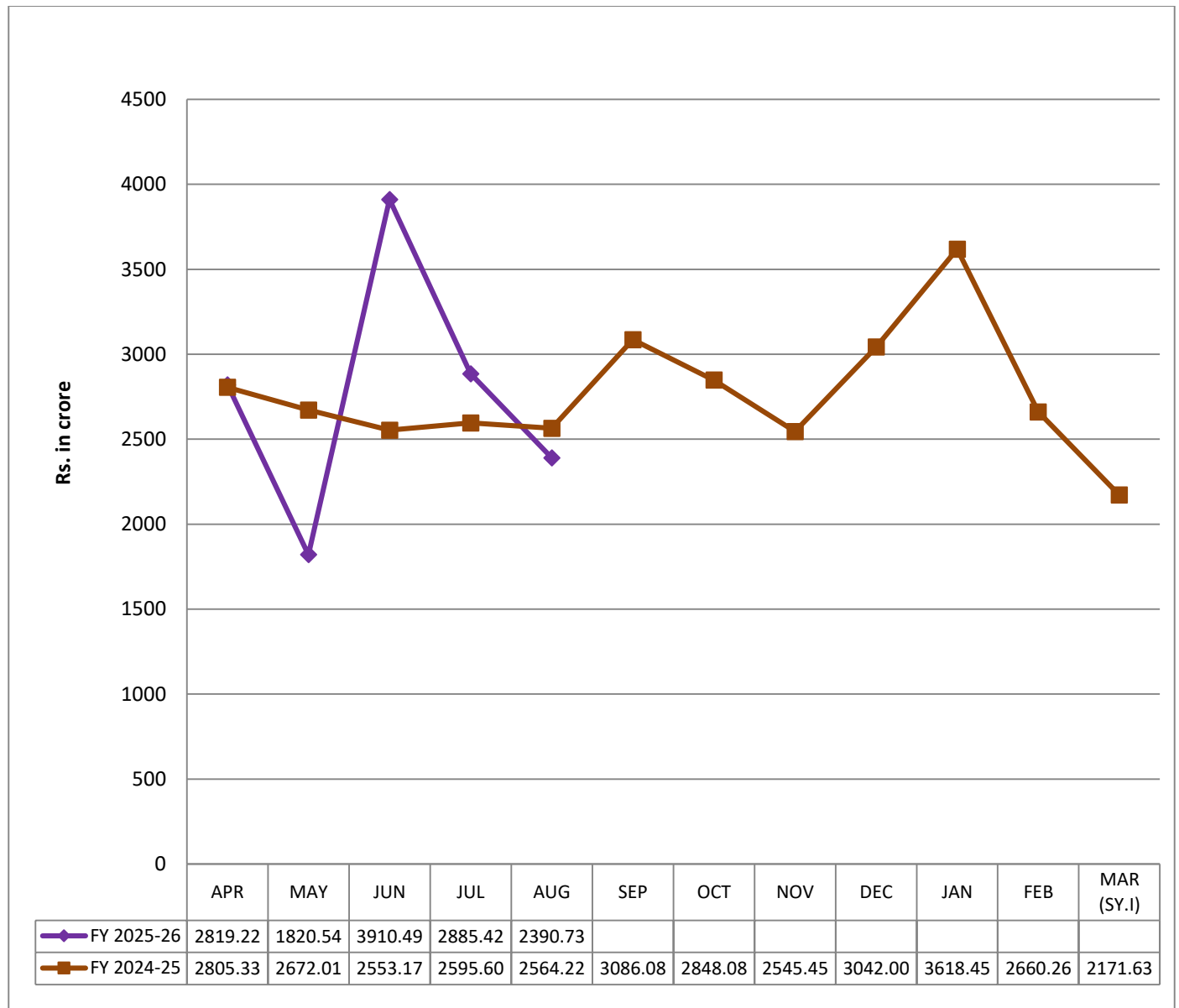

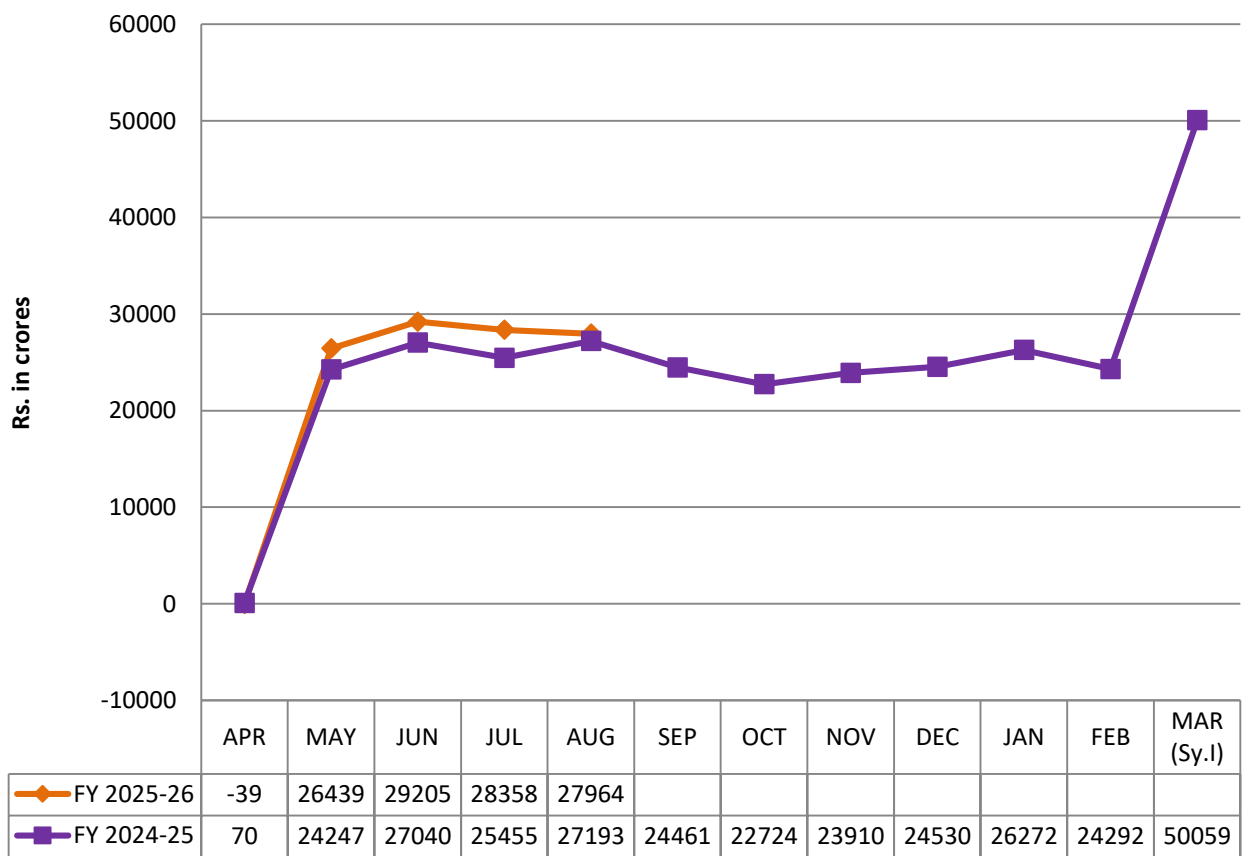

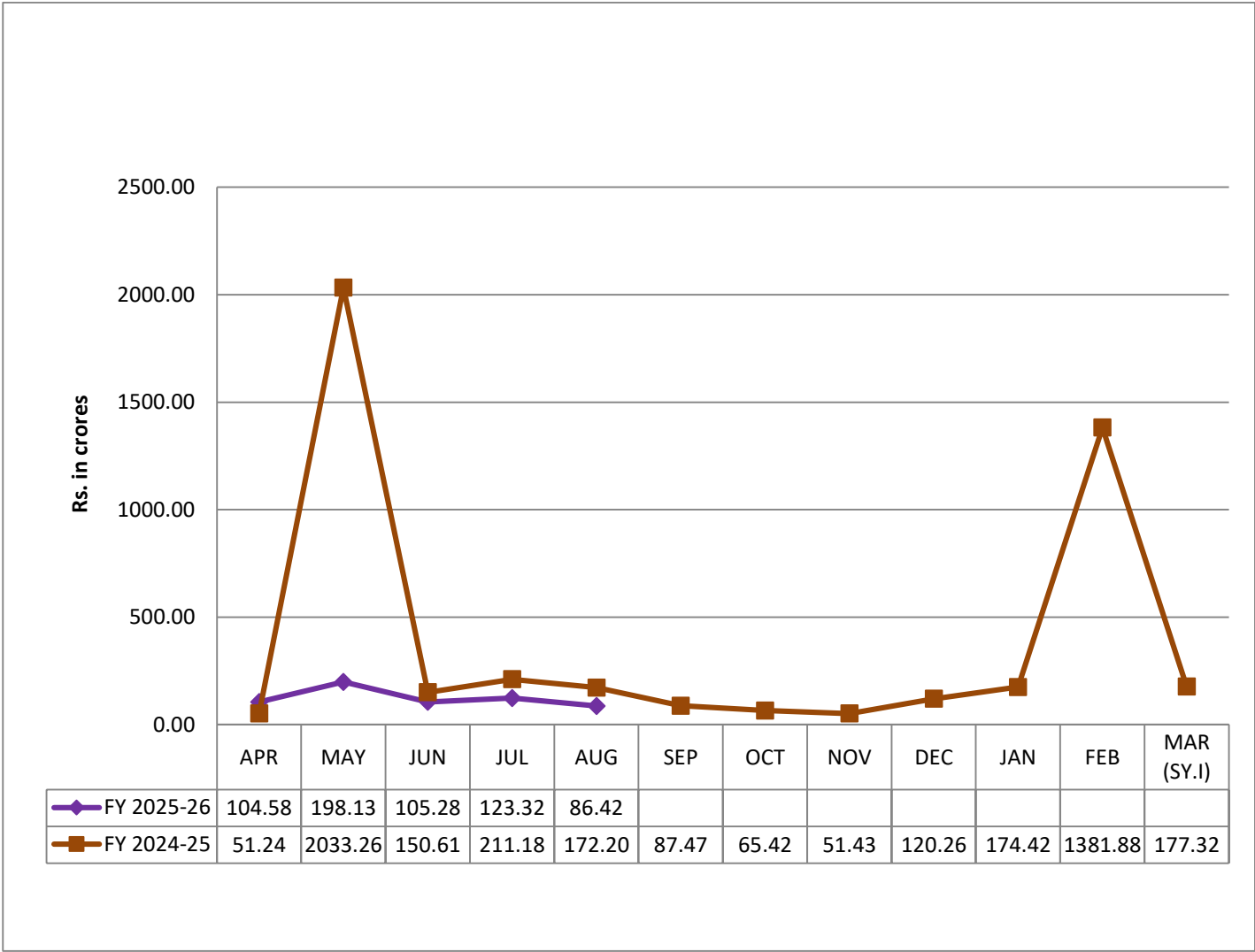

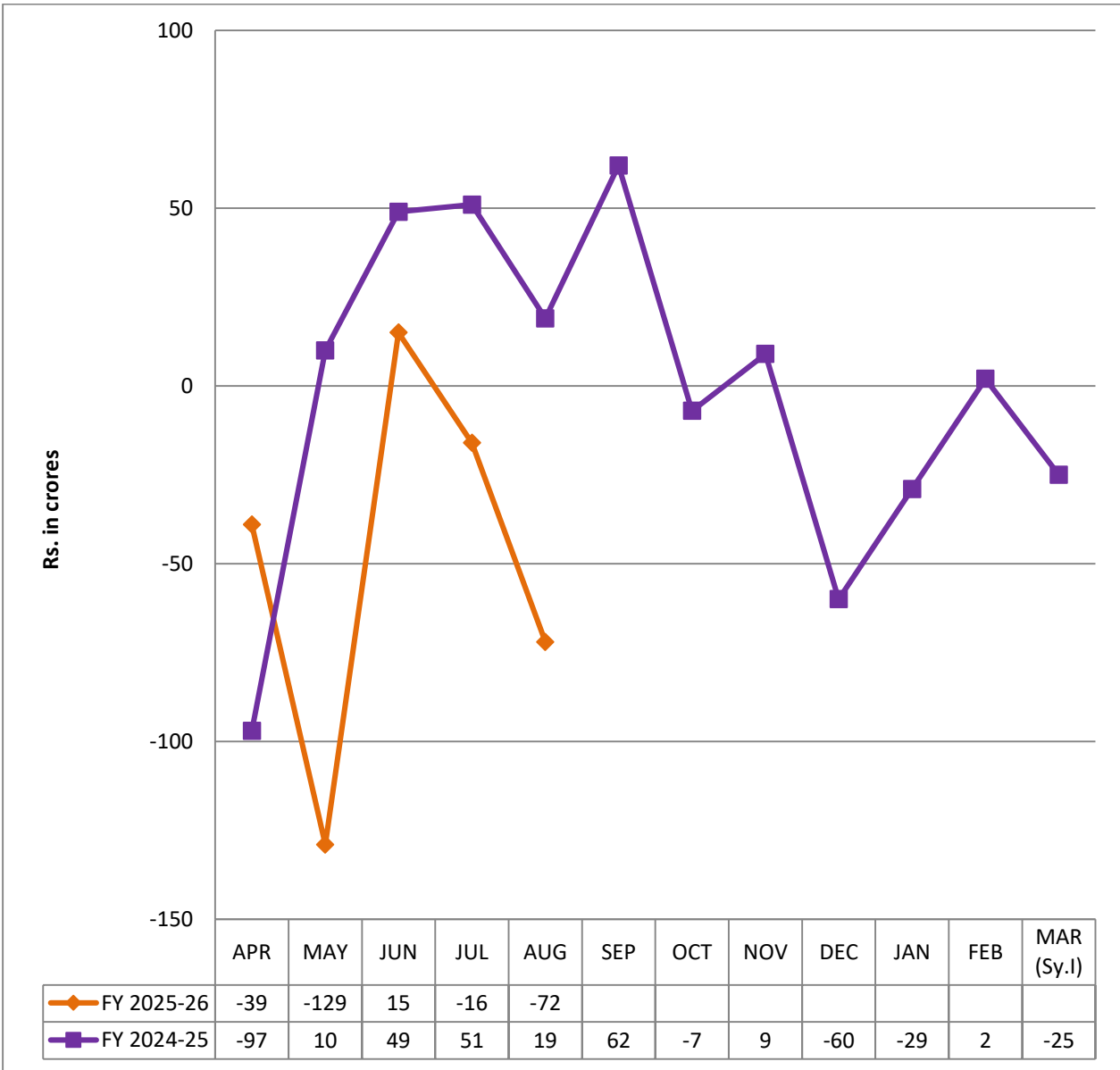

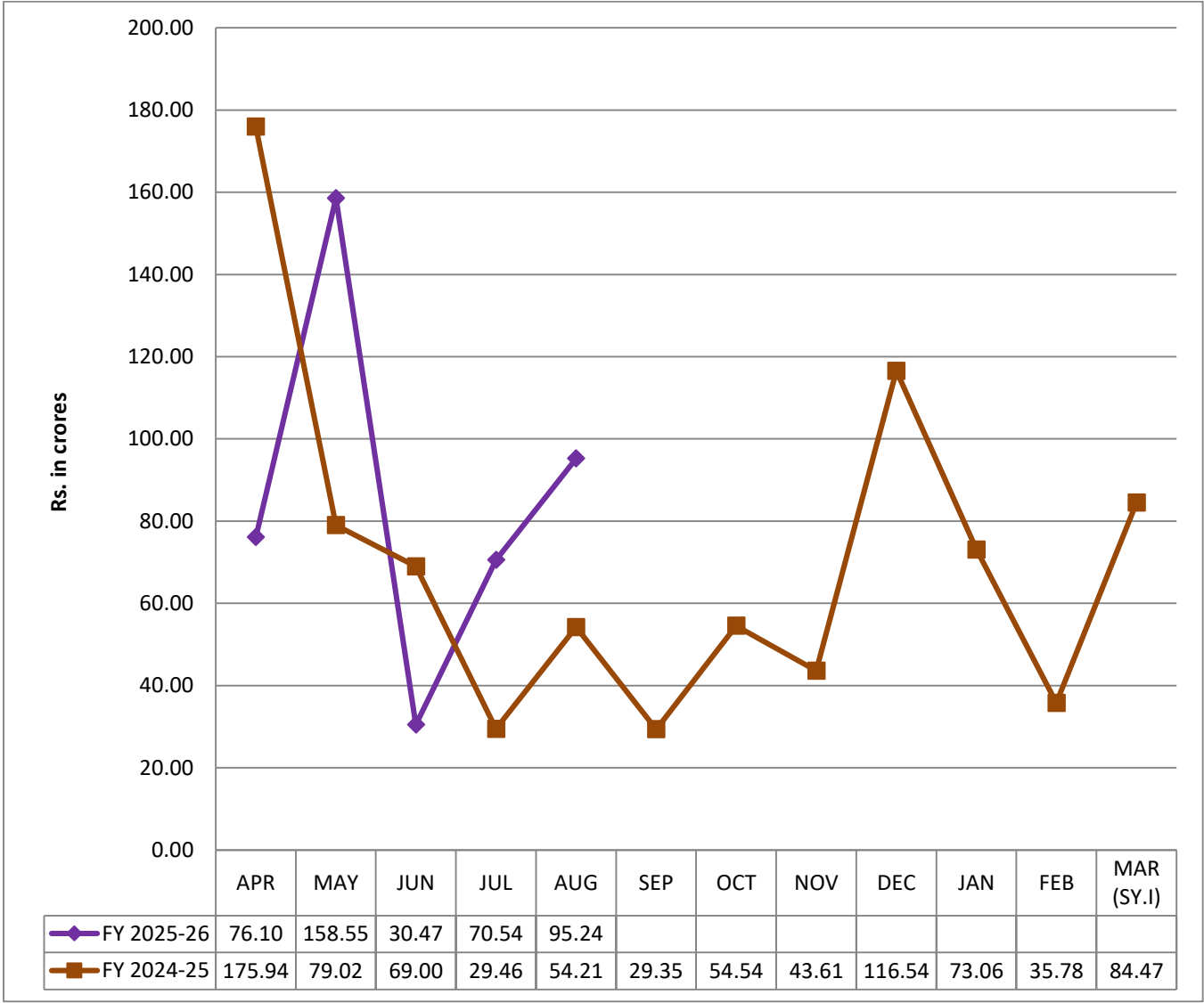
